E.Q.U.I.P. Enterprises:Serving customers by placing employees at the forefront

E.Q.U.I.P. Enterprises, Inc. is a San Antonio-based vocational rehabilitation nonprofit that is also a Community Rehabilitation Program (CRP) in the Texas State Use *WorksWonders* Program. As a CRP, E.Q.U.I.P. is a respected employer of veterans and others with disabilities while also ensuring the highest level of quality service for its customers.

Fernando Rodriguez has been an employee of E.Q.U.I.P. for the past six years, where he oversees the Live Oak County Safety Rest Area just outside of San Antonio, making sure it's clean, that restrooms are stocked with soap and paper products, and the grounds are maintained. As part of his daily tasks, he replaces toilet paper, takes out trash, scrubs windows, mops floors, rakes gravel, sweeps sidewalks and pressure washes the parking lots.

Raul Tintori, E.Q.U.I.P.'s CEO, says it's employees like Rodriguez who help the organization achieve its mission.

"I've always credited the success of this company to the employees themselves," Tintori said. "It all comes back to them."

Founded in 2007, E.Q.U.I.P. currently oversees 20 safety rest areas across Texas and offers custodial services, grounds and facility maintenance, and IT services to state agency customers including the Texas Department of Transportation, Texas Health and Human Services Commission, Texas Department of Public Safety and Texas Department of Assistive and Rehabilitative Services. These contracts are facilitated by WorkQuest.

In addition to being given a job placement within E.Q.U.I.P., employees also receive job training that prepares them for a future

job in the private sector, if they so choose. Mike Stevens, vice president of E.Q.U.I.P., says this practice is important to E.Q.U.I.P.s goal of making sure everyone in the disabled community has access to the opportunities in which they're interested.

"As a company, we're always pursuing areas where we can reach out and expand our mission," Stevens said. "Those in the disabled community are often the hardest-working and sincerest employees. They really just want to be given a chance."

Rodriguez is thankful for his second chance at a fulfilling career. After suffering a stroke 11 years ago, he was unable to continue working as a flooring contractor. He later learned about E.Q.U.I.P. at a job fair and thought it could offer him some stability and a renewed sense of purpose.

"I've had previous experience working with people who needed my help," Rodriguez said. "It was rewarding to care for people, and now I do that in a different way."

Tintori says that serving employees with respect and dignity ensures that customers receive the same level of service, which strengthens the relationships E.Q.U.I.P. has with its customers and solidifies continued job opportunities for individuals with disabilities.

"We like to come up with new ways to grow in our ability to serve our customers and our employees," Tintori said. "Whether that's adding new lines of services or building relationships with other communities around Texas, we want to be the employer who gives people a chance."
