Tejas Roadrunners:Collaborating to eliminate workplace barriers

Since 2022, Tejas Roadrunners has proudly offered meaningful employment opportunities to individuals with disabilities in Huntsville and its surrounding areas.

Tejas Roadrunners, a Community Rehabilitation Program in the *Works Wonders* Program, is connected with State Use contracts through WorkQuest which allows the organization to continue to thrive and provide jobs. The Tejas Roadrunners team, which consists of 11 employees, works on multiple contracts where they handle janitorial tasks for organizations including Stephen F. Austin State University, Texas Department of Transportation, Houston County and Shelby County, to name a few.

Mayra Sanchez, president and CEO at Tejas Roadrunners, started the company with a mission to employ people with disabilities who face language barriers in the workplace.

"I have a passion for helping others, so I always help my employees with tasks like filling out applications, translating and anything they may need help with," said Sanchez. "It is an overwhelming process, so I like to create a connection with them and make them feel comfortable."

The employment opportunities provided by Tejas Roadrunners have had a profound impact on its employees, including Paulina

Corral, who works as a cleaning crew member and assists with the company's administrative services. Having a job that fosters interactions has helped her create a collaborative environment that allows her to enjoy what she does.

"I like working in an intimate environment where I get to interact with my coworkers and other people," said Corral. "Whenever you do something that you love, it doesn't really seem like a job. At work, I get to take a break from everything that is going on in my life, and at the same time, it is benefiting me by helping me make money."

Working in a collaborative team is one of Corral's favorite parts of the job. Sanchez leads her team by example and her helping hand does not go unnoticed by her employees.

"Our supervisor is with us all the time and I like that we are all just equal here, we're all in it together," said Corral. "I feel like having that relationship with your supervisor is really important."

As for Tejas Roadrunners, they look forward to continuing to serve their community by providing individuals with disabilities with rewarding job opportunities to help them provide for themselves and their families.
