Nichole Nobles of Travis Association for the Blind recognized with 2020 Artie Lee Hinds Award

On Sept. 23, Nichole Nobles of the Travis Association for the Blind was honored by WorkQuest with the 2020 Artie Lee Hinds Award during its virtual celebration. The award recognizes an outstanding employee of a community rehabilitation program (CRP) for their leadership, dedicated service and commitment to excellence.

During her eight years with the Travis Association for the Blind, Nobles has continuously demonstrated her leadership ability, natural sense of responsibility and caring personality. She often uses her expertise to help guide newer co-workers and jumps at the opportunity to support her peers in any way she can.

Nobles works in the skin care department on the GOJO contract, where she is responsible for core duties, such as palletizing, weighing cases on the line, inspecting boxes and ensuring items are labeled correctly, as well as any additional tasks that come up.

"Nichole is one of the best workers," Arabeli Olmos, Nobles' supervisor, said. "She can memorize anything and everything, fast and accurately."

While in college, Nobles' goal was to join the military after graduating. However, after realizing that life had other plans, she found the Travis Association for the Blind, where she is serving her community in a whole new way.

"If you're in a positive mood, it makes the day go by faster," Nobles said. "It's fulfilling knowing that we're contributing to society and helping in some way."

Nobles also practices jiu jitsu, a martial art she was introduced to while working at the Travis Association for the Blind. Recognizing that the opportunity to learn self-defense is often overlooked in the blind community, Nichole began teaching classes to provide other individuals with this invaluable skill. This practice has built Nobles' confidence in herself and her abilities, and it has helped her recognize that each person has something to contribute.

During its first-ever virtual event, WorkQuest welcomed participants to its 13th annual Artie Lee Hinds Award celebration, which was streamed over Zoom and YouTube Live, on Sept. 23. The online event recognized supporters of the State Use Works Wonders Program, which provides employment opportunities for Texans with disabilities—an effort that has been especially crucial since the onset of the COVID-19 pandemic.

Attendees, which included award nominees and their families, WorkQuest board members and employees, community rehabilitation program (CRP) representatives and purchasing entity representatives, logged on to celebrate

the accomplishments of Texas employees with disabilities, as well as the dedication of WorkQuest and its partner CRPs that make it all possible.

As in previous years, WorkQuest honored several CRP employees during the event. Van Bui of Endeavors Unlimited was recognized as the Most Motivational Employee, and Leroy Lacey of Goodwill Industries of East Texas was honored as the Most Inspirational Employee.

Attendees were treated to video messages from special guest speakers, including several representatives from the Texas Workforce Commission (TWC)—Chairman Bryan Daniel, commissioner representing the public; Ed Serna, executive director; and Michael Hooks, director of the office of disability employment strategies. TWC has served as a valuable partner in aiding employment growth for Texans with disabilities.

Later in the event, WorkQuest recognized the Top 10 customers who purchase products, services and temporary employment services through the *WorksWonders* Program. These customers include multiple state, city and county agencies

and organizations. Agencies new to this year's lists were the Texas Juvenile Justice Department for its purchase of services, and the Texas General Land Office and Texas Department of Family and Protective Services for purchasing temporary employment services.

Throughout the event, attendees were reminded of how important award nominees, and all employees in the *WorksWonders* Program, are to keeping the Texas economy strong during the COVID-19 pandemic. The program featured videos showcasing the standout employees recognized throughout, including Bui and Lacey, as well as the winner of the event's namesake award, the 2020 Artie Lee Hinds Award, which was presented to Nichole Nobles of the Travis Association for the Blind. Nobles was honored for her leadership, dedicated service and commitment to excellence.



We See Things Differently by Dinah Rodriguez

Dinah describes herself as an observant child who loved to draw, color, and paint. She struggled with different health challenges throughout her life, including vision and hearing loss. It wasn't until much later—in her 40s—that she was diagnosed with Major Depressive Disorder and General Anxiety. Dinah experienced a major turn of events in 2018 after visiting a family doctor and mentioning her blurry vision. She was referred to an eye doctor and diagnosed with retinitis pigmentosa, which in turn lead to a diagnosis of Usher syndrome—a rare genetic disease that causes hearing and vision loss. According to Dinah, art has helped her find peace

Dinah says, "Even though we may have a disability and see things differently, we are still useful and capable of producing work. We just need to have faith that we are valuable- being different doesn't mean we can't provide for ourselves! We love what we are gifted to do, and there is no stopping us from succeeding. We appreciate everyone who has looked at us in this way." She goes on to add, "With

who has looked at us in this way." She goes on to add, "With the knowledge of professional people around me during these years—from my fourth grade teacher to my family detect on my thoragist. I have begun to flowing."

Today Dinah is a successful artist with legal blindness who continues to grow her knowledge and creativity as she produces work in digital and fine art. She publishes her artwork to different sites where she adds them to product like mugs, t-shirts, journals, and much morel She created a children's book and three coloring books, all of which
